## **ALREADY HAVE A FABRIC SHELTER IN PLACE?**

The primary reason that RMA became involved in the supply of fabric shelters to members was due to the history of some structures failing to withstand Alberta's extreme weather conditions. RMA and Coverco have developed a Structure Maintenance Program to provide members with preventative measures for all makes of fabric shelters to mitigate the risk in maintaining these essential structures.

## **HOW DO I USE THE FABRIC SHELTER PROGRAM?**

Due to the Fabric Shelter Program being established through the Request for Proposal (RFP) process and advertised through the Alberta Purchasing Connection (APC), this program is deemed trade compliant through the requirements of the Canadian Free Trade Agreement (CFTA) and the New West Partnership Trade Agreement (NWPTA). To use the program, the municipality simply posts a Notice of Planned Procurement (NPP) on APC stating that they intend to use the RMA Trade Program, then contact Coverco Buildings to discuss your needs. Coverco will provide a price based on your needs and desired options. This increases the savings due to not needing to hire for third party engineering and tendering services.
